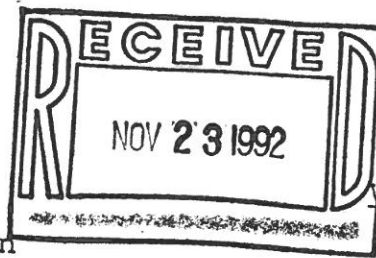

Dear Ms. Clifton:

In accordance with the ACNM Disciplinary Procedures, Section IX.A., I am writing to notify you of the disposition of the longstanding complaint against you. Your entire disciplinary file was considered during a closed session of the ACNM Board of Directors' meeting on October 31, 1992. Based on careful review of your folder and noting no response to the August 3, 1992, letter from me, the ACNM Board of Directors determined that you had not met the stated conditions of your suspension of February 9, 1990.

DISCIPLINARY ACTION

On October 31, 1992, the ACNM Board of Directors voted to revoke your ACNM certification. You were notified on several occasions since 1990 of the need to submit the requested documentation of the conditions of your suspension in a timely manner. On August 3 and again on August 29, 1992, you were notified that if the missing materials were not submitted by October 10, 1992, the ACNM Board of Directors would take action toward de-certification. Nothing was received from you either before or after the October 10th deadline.

Pursuant to Section IX.B. of the ACNM Disciplinary Procedures, the Board will notify the complainant, the ACNM Membership Coordinator and the Missouri licensing board of this final action against your ACNM certification. Likewise, pursuant to Section X of the enclosed Disciplinary Procedures, you may appeal this decision of de-certification within ninety days (90) of receipt of this letter.
